Fairfield Glade Community Club Household Trash/Sanitation Removal Policy

(Approved by the Fairfield Glade Board of Directors on March 23, 2017.)

1.0 Purpose:

1.1 The purpose of this policy is to communicate to residents/customers Fairfield Glade Community Club's Sanitation's household refuse collection procedures.

2.0 Scope:

- **2.1** This policy applies to those who live in Fairfield Glade and Commercial customers within Fairfield.
- **2.2** To communicate to our residents/customers what refuse will or will not be collected by the FGCC's Sanitation Department.
- **2.3** To communicate when and where to place household refuse for collection along with general procedures.

3.0 Definition:

3.1 Household Refuse: This is refuse from inside the home such as food, food containers, bottles, cans, disposables, etc.

4.0 Policy:

4.1 Collection Day, Where to Place the Refuse and What Time

- **4.1.1** To find out your collection day call the FGCC Administration Office at 484-3780.
- **4.1.2** Place your household refuse alongside the roadway near the end of the driveway (not in the drainage ditch).
- 4.1.3 Have your household refuse out by 8:00 a.m. on your collection day. Your refuse can be set out the day before your collection day but no sooner than 5 p.m. If left out sooner, a fine may be imposed (see section 4.7 below).
- **4.1.4** If animals spread refuse due to not being in cans, the refuse will not be picked up/cleaned up by Sanitation personnel.

4.2 Refuse That Will be Collected

- **4.2.1** Household refuse
- **4.2.2** Needles/Syringes Break off the needle and place the entire apparatus in a leak proof puncture resistant container (a milk jug or two liter bottle is acceptable).
- **4.2.3** Paint that is dried up with the lid off.

4.3 Refuse That Will Not be Collected

- **4.3.1** Appliances/Furniture water heaters, washers, dryers, stoves, refrigerators, televisions, microwaves, air conditioners, computers, monitors, couches, chairs, tables, beds, desks, etc. If items are usable, please contact one of the local charities for pick up. If not usable, these items can be taken to the Cumberland County Recycling Center (CCRC) located at 96 Maryetta Street in Crossville.
- **4.3.2** Tires these can be taken to the CCRC for a fee.
- **4.3.3** Motor oil and anti-freeze these can be taken to the CCRC.
- **4.3.4** Batteries automotive, motorcycle, lawnmower, etc. The rechargeable batteries can be taken to the CCRC.
- **4.3.5** Florescent light bulbs these can be taken to the CCRC.
- **4.3.6** Miscellaneous Metal lawn mowers, grills, propane tanks etc. These can be taken to the CCRC.
- **4.3.7** Liquids paint, primer, stain, Freon, gear oil, transmission fluid, gasoline, acids, insecticides, solvents, poisons, etc. These items can be taken to the CCRC <u>once a year</u> usually in October. This is usually advertised but you can call them at 484-9328 closer to October to get the exact date.
- **4.3.8** Building Materials lumber, drywall, insulation, roofing shingles, plywood, siding (wood, vinyl, etc.), decking, flooring materials, concrete, bathroom and kitchen fixtures, wire, fencing, etc. Check with Waste Management in Crossville at 456-2434 to see if they take these items.
- **4.3.9** Yard Waste leaves, sticks, branches, bushes, plants, and lawn clippings. These items can be taken to the Leaf/Brush dump area located at 311 Drew Howard Road.
- **4.3.10** Small Dead Animals bury these.
- **4.3.11** Ammunition and Explosives Call Public Safety at 484-3785.

4.4 Refuse Cans, Weight Limit and Garbage Bag Size

- **4.4.1** Refuse cans are strongly recommended to be used. All cans must be removed from the collection area by 7 p.m. on your scheduled collection day. If left out later, a fine may be imposed (see section 4.7 below).
- **4.4.2** The weight limit is no more than 40 lbs. per bag/can.
- **4.4.3** Bags are to be used and tied even if the refuse is put in garbage cans and are to be no smaller than a 13 gallon size.

4.5 Moving In and Household Cleaning Out

- **4.5.1** No large quantity or large boxes will be collected. The boxes need to be broken down and can be taken to the Convenience/Recycling Center located off of Peavine Road on Bean Pot Campground Road (next to Leisure Kraft Marine) to be recycled.
- **4.5.2** No house clean out will be collected. Residents will need to rent a dumpster. If any items/refuse is left outside the home, a fine may be imposed (see section 4.7 below).

4.6 Missed Putting Your Refuse Out and Inclement Weather

- **4.6.1** Keep the refuse until your next collection day or take the refuse to the Convenience/Recycling Center.
- **4.6.2** If the Sanitation route is cancelled due to inclement weather, no make-up day will be scheduled. Please remove refuse from the curb and store until your next collection day or take the refuse to the Convenience/Recycling Center.
- **4.6.3** Do not dispose of your refuse in public receptacles.

4.7 Fine Structure

4.7.1 A fine will be imposed per the FGCC Fine Schedule approved by the Board of Directors.

If the Sanitation Crew finds procedures not being followed, they will leave a tag at your residence explaining the violation.

FGCC encourages you to consider recycling more of your trash by taking recyclable materials (i.e., paper/books, cardboard, cans, #1 & #2 plastics and glass) to the Convenience/Recycling Center.

A yearly holiday refuse collection schedule will be posted on the FGCC website and sent out in an e-blast before each new year. For each holiday we have off, there will be a posting in the Glade Sun and an e-blast sent out prior to the holiday so you'll know if your scheduled refuse collection day has changed.
